### Committee Reports

- 1. Public Safety Committee The Committee met this month to discuss hiring part-time firefighter and discussed the police car for the K-9. Next week's meeting will be cancelled.
- 2. Mayor's Report No report.
- Code Committee Ms. Gilliam provided overview of the Inspection Program, Code Sweeps/Ordinance Violations, Merchant Street Project, Abandoned Vehicles, and High Grass. A Code meeting will be set up to discuss a plan for the program moving forward into the next year. Topics to be discussed are Rental Inspection Program, property maintenance, snow and ice removal, and high grass.
- 4. Public Works Committee No report.
- 5. Parks and Recreation Committee Mrs. Miller reported that the Ambridge Youth Football approached her to see if the Recreation Committee would participate with them in a Trunk or Treat event on October 20, 2022. The Borough can buy the candy. Chief Larrick heard that the band would participate and that kids could trick or treat in the parking lot. A fire truck will be set up for candy.

- 7. Engineer's Report Mr. Brunner stated that aside from the Road Program, NIRA has submitted annual MS4 Report to DEP, proposed new stormwater ordinance, developed new language for street opening ordinance, developed drawings for the Laughlin Library renovation projects, completed Site-Distance Study for the intersection of Ridge Road and Wilson Avenue and recommended installation of stop signs at that intersection.
- 8. Solicitor's Report Mr. Chesney stated that his primary item was discussed on the conditional use hearing in two days. A couple of other things being worked on are fire properties finalizing the documents. Chief DeLuca asked about the ordinance on the stop signs. Mr. Chesney will begin to draft the amendment to the ordinance.
- 9. Manager's Report Mr. Leone received health care insurance renewal; we are looking at 9% increase in the health care cost as an FYI for budget purposes and union negotiations. It's crunch time for some of our grant applications, the CFA multi-modal as well as RCAP grants. Those announcements are expected very soon. There are some conflicts with the Workshop meeting date

so we might be cancelling that meeting. There is a meeting the following week on November 1 on the budget. Discussion on November's meeting being on election day.
